

CONFIDENTIALITY AGREEMENT

INTRODUCTION

This Confidentiality Agreement (the "Agreement") is entered into by and between the following affiliated entities:

BELLANDE TECHNOLOGIES CORPORATION INC., a corporation organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BTC")

BELLANDE RESEARCH INNOVATION ORGANIZATIONS, an organization organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BRIO")

BELLANDE FIRMS, a business entity organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BF")

BELLANDE LABORATORIES, a business entity organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BL").

BTC, BRIO, BF, and BL are collectively referred to herein as the "Bellande Entities" and individually as a "Bellande Entity."

PURPOSE

This Agreement acknowledges that Letters that Represent Company Secrets Corresponding to this Agreement do not require registrations or formal filings to maintain their confidential status between the Bellande Entities.

GENERAL TERMS

1. INFORMATION SHARING

The Bellande Entities commit to a policy of responsible information sharing that balances operational transparency with appropriate confidentiality measures. All Bellande Entities may freely share non-confidential business information, publicly available research findings, and general organizational knowledge in accordance with applicable laws and regulations.

2. CONFIDENTIALITY COMMITMENT

As soon as the any information in any shape or form that's under NDA or Associated with Bellande Entities public or outside of Bellande Entities automatically are under Copyright. Any unauthorized disclosure to the above-restricted parties will constitute an automatic Copyright violation and NDA violation.

5. COMPLIANCE WITH LAWS

All information sharing activities between Bellande Entities shall comply with applicable laws and regulations in the relevant jurisdictions, including but not limited to data protection laws, competition laws, and intellectual property laws.
