

# MASTER SERVICE AGREEMENT

## PARTIES

**BELLANDE TECHNOLOGIES CORPORATION INC.**, a corporation organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BTC")

**BELLANDE RESEARCH INNOVATION ORGANIZATIONS**, an organization organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BRIO")

**BELLANDE FIRMS**, a business entity organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BF")

**BELLANDE LABORATORIES**, a business entity organized under the laws of an international jurisdiction, with its principal place of business established internationally, operating across global markets without geographical limitation ("BL")

BTC, BRIO, BF, and BL are collectively referred to herein as the "Bellande Entities" and individually as a "Bellande Entity."

1. **Unrestricted Communications Rights:** Each Bellande Entity and its representatives, agents, employees, contractors, officers, and directors (collectively, "Personnel") shall have the unrestricted right to communicate, correspond, negotiate, and engage in discussions with ANY individual, entity, organization, corporation, government body, or other party located in ANY COUNTRY worldwide without geographical limitation or restriction.
2. **Scope of Communications:** The right to communicate globally shall include but not be limited to:
  - Business negotiations and discussions
  - Research collaborations
  - Technical consultations
  - Service offerings and proposals
  - Partnership arrangements
  - Exchange of information and data
  - Market research and business development activities
  - Any other lawful business, research, or operational communications
3. **No Geographical Limitations:** This Agreement explicitly acknowledges and establishes that the Bellande Entities are not subject to any geographical limitations regarding their communications, and may freely engage in discussions with parties from ANY COUNTRY, territory, or jurisdiction worldwide.
4. **Compliance Responsibility:** While exercising these unrestricted global communications rights, each Bellande Entity remains responsible for compliance with applicable international laws, export controls, and sanctions that may apply to specific types of communications or specific jurisdictions.
5. **Authority:** Each Bellande Entity hereby affirms and declares that it possesses full authority to communicate with ANY party worldwide as necessary to conduct its business operations, research activities, and other legitimate organizational functions.
